This page describes the ways by which the website www.ontoartecatalogue.com is managed in reference to the processing of personal data of users.

This information for the processing of personal data are treated according to the art. 13 of the Italian Legislative Decree 196/03 (the Privacy Code) and subsequent amendments and additions, for service users of our site, which are provided via the Internet.

The owner of treatment

The owner of the personal data of individuals identified or identifiable treated following the consultation of our site is F.O.I.L.srl (Ontopsicologia Editrice), at the head office of Piazza E. Fermi 1, 05100 Terni (Italy).

Place and purpose of data processing

The treatments related to the services on this web site are, in charge and content, managed by employees / co-operators of F.O.I.L. srl.

No data from the web service is advertised or distributed to third parties.

Personal data provided by users requesting services are used only to perform the services required and are not disclosed to third parties unless the notice is required by law or obligations is strictly necessary for the performance of requests.

Navigation Data

Computer systems and software for the functioning of this website acquire, during their normal exercise, some personal data transmitted with communication protocols of the Internet. This information is not collected to be associated with identified, but by their very nature could, through processing and associations with data held by third parties, allow users to identify. This category of data includes IP addresses or domain names of the computers used by users who connect to the site, the URI (Uniform Resource Identifier) of the resources required, the time of the request, the method used to make the request to the server, the size of files obtained in response, the numerical code indicating the status of the response from the server (successful, error ...) and other parameters relating to the operating system and computer environment. This data is used only to obtain anonymous statistics on the use of the site and to check the proper operation and is deleted immediately after processing. The data could be used to ascertain responsibility in case of hypothetical crimes against the site.

Data provided voluntarily by users

The optional, explicit and voluntary e-mail to addresses listed on this site involves the subsequent acquisition of the sender's info necessary to respond to requests, as well as any other personal data included in the message.

Cookies

The cookies and textual element are inserted into the hard drive of a computer only after approval. Cookies have the function to streamline the analysis of traffic on the web or to report when a site is visited and allow web applications to send information to individual users. No data user is acquired from the site. There is not any use of cookies for the transmission of personal information.

Option to provide data
